- Stream requires strimming of weeds and clearing of concrete Clerk to speak to ProGround
- Drains to be checked as the ones by the entrance are blocked with leaves.
- Councillors were pleased with the clear condition of the bin store.
- Stream on the waste land outside the burial ground requires clearing Clerk to speak to Steve Hyder at TDC and the Environment Agency
- Concern had been expressed by one of the funeral directors that the plot markers had been removed however, this is not the case. **DWe and DWa will insert the markers further into the ground when the ground softens**.

5. <u>Future Works</u>

- Extending and widening of the path
- Erecting memorial and semi-circular bench at far end of burial ground
- Ramp for disabled access by parking area
- Repair/replacement of gates and possible installation of pedestrian gate

6. <u>Maintenance Contract</u>

It was noted that the current maintenance contract comes to an end in March 2015.
