Oxted Parish Council strongly objects to this application on numerous grounds. The case for affordable housing is not feasible on the basis that the location is in a narrow country lane, with a bus stop at least a mile away, the roads are unlit and there is no pavements.

The Royal Oak is on green belt and development of its car park will cause sewage and environmental issues including cutting tree roots of ancient woodland trees to lay new foundations.

The public house is recognised as a community asset as it is well utilised by the nearby community, walkers, horse riders and cyclists and provides the opportunity of employment to local residents.

Should this application be permitted it will set a precedent for further

overdevelopment of sites of outstanding natural beauty in the area.
