Demolition of existing conservatory. Conversion of garage to habitable accommodation in association with two new roof lights and extension to existing vehicular crossover. 23 Boulthurst Way, Hurst Green RH8 0HT Applicant: Vanessa Fowler **The Parish Councillors made no comment**

4.3 TA/2016/485

Erection of hip to gable roof extension to east elevation and dormer to north elevation in association with conversion of loft space to habitable accommodation. Formation of three roof lights to south elevation. (Certificate of Lawfulness for a Proposed Use or Development) 12 Meadowlands, Hurst Green RH8 9BG

4.4 TA/2016/484

Erection of single storey side and rear extensions 12 Meadowlands, Hurst Green RH8 9BG Applicant: P Denyer **The Parish Councillors made no comment**

4.5 TA/2016/290

Demolition of existing outbuildings to the side and rear. Erection of single storey side and rear extension to form extended bar area, dining room and kitchen and internal works to existing pub. Formation of extended car parking area, access paths and patio terrace. Re-routing of existing farm track to the adjacent site and landscaping.

69 Tanhouse Road, Oxted RH8 9PE

Applicant: G Price

The Parish Councillors object to the inappropriate development of the car park in the Green Belt; the proposed development is intrusive on the neighbourhood and the height of the kitchen area is excessive. The area is renowned for flooding and the Parish Council want to be assured that this issue has been addressed.

4.6 TA/2016/524

Conversion of loft to habitable accommodation in association with extension to roof. 10 High Street, Oxted RH8 9LP

Applicant: Stone

The Parish Councillors made no comment however are aware that this is a large development in a conservation area. The roof level will be out of proportion to the building.
