- **1.** <u>Apologies for absence:</u> to receive and accept apologies for absence. There were none

4.1 TA/2017/2533

Erection of dormer to rear elevation in association with conversion of loft space to habitable accommodation. Installation of roof lights to front and rear roof slopes.

17 Juniper Close, Hurst Green RH8 0RX

Applicant: Smith

4.2 TA/2017/2402/TPO

TPO 59 (Godstone). G1 Holly and Holm Oak; crown lift to 5 metres above ground level.

8 Parklands, Oxted RH8 9DP

4.3 TA/2017/2498

Demolition of existing garage. Erection of detached annex providing ancillary residential accommodation.

23 Hurstlands, Hurst Green RH8 0HF

Applicant: Alex and Gemma Lombardi

The Parish Councillors object to this application due to being overdevelopment of the site, there is loss of privacy to the neighbouring property and further request that should the application be approved there is increased privacy granted to the neighbouring property which could be achieved by the applicants erecting higher boundary fencing or hedging. The Parish Councillors expressed concern that if this application is approved the owners could request permitted development in the future. The Councillors request that this is not sold as a separate dwelling and is not to be sublet to anyone outside of the family.

4.4 TA/2017/2493

Erection of two storey side extension, single storey rear extension and chimney stack to side elevation. Formation of pitched roof canopy to front elevation. Alterations to fenestration incorporating external render finish.

12 Comforts Farm Avenue, Hurst Green RH8 9DH

T1 Lime – Reduce in height by 3-4 metres to a finished height of 18-19 metres and reduce lateral branches in proportion. Deadwood groups of pines and conifers (exempt works).
