  - Brambles along fence edge in trees require cutting back
  - Hedge along the stream overgrown and requires cutting right back prior to the inclement weather setting in
  - Suckers on rose bushes need removing
  - Garden of Remembrance and adjacent area requires grass to be cut
  - Epicormic growth on base of trees to be removed
  - Palm tree to be removed
  - Long grass under trees to be cut
  - Overgrown shrubs along perimeter fence to be cut

- Fencing repair the Clerk will arrange for the rest of the staples to secure the fence to be installed.
