G1: Two Goat Willows with signs of heave and longitudinal cracking within woodland to rear of property felled. Remove hazard.9 Hamfield Close, Oxted RH8 0NG

Erection of a mobile shelter Stable Building, Oxted Mil, Spring Lane, Oxted RH8 9PB Applicant: Lorraine Kruger **Comment: The Parish Councillors object to this application as the proposal is not a mobile shelter being 7.3 x 3.6. It is not to be used as a separate dwelling**

4.3 TA/2018/1783/TPO

On Map Ref. 33515: 01 Yew - fell due to location of tree at top of steps. Lateral branches will need to be pruned very aggressively and regularly to avoid obstacle. Client therefore wishes to remove this tree prior to tree maturing to anything of amenity value.

02 Dying Holly, Laurel & Sycamore – reduce height to 3m to suitable growth pointes below deadwood on holly. Reduce height of remainder to create hedge in order to reduce to live growth due to top being heavily sun scorched and dying back.

Map Ref. 33642: 510 Oak - remove dead stem due to cavity on main stem at 9m. 512 Beech - crown lift by removal of 2x 30mm 5m long secondary branches over driveway due to branches overhanging driveway. 514 Sycamore - remove 2x elongated 40mm 6m long low branches over driveway back to point of origin due to branches overhanging driveway. G519 3x Hornbeam & 2x Beech - crown lift to a height of 5m from ground level on north-eastern tree in group to match remainder of group. 524 Sycamore - remove epicormic growth & ivy from ground level to a height of 3m on main stem by removal of 3x 30mm stems over bridge to enable re-inspection. 531.1 – Reduce height by 3m (from 9m – 6m) to encourage new growth. 535 – Reduce height by 3-4m (from 20m – 17/16m) and reduce laterals by 2-3m (from 6m-4/3m) in length. 536 – Reduce height by 4-5m (from 17m – 14/13m) to suitable growth points.
