- **1.** <u>Apologies for absence:</u> received and accepted apologies for absence. Mrs Katherine Saunders due to a prior commitment

Oak T2 (TPO T7): Remove epicormic shoots flush to the main stem (or branch) up to a height of 4 metres above ground level; clean out to remove all dead, diseased, dying broken, hanging branches and stubs throughout the crown. Oak T6 (TPO T6): Clean out to remove all dead, diseased, dying broken, hanging branches and stubs throughout the crown. Oak T7 (TPO 5): Clean out to remove all dead, diseased, dying broken, hanging branches and stubs throughout the crown. Reasons for works: routing management works for safety and public amenity.

4.2 TA/2018/1217/TPO

(W1) T1: Sycamore on left-hand side of rear garden crown reduced in height by approximately 2.5m from approximately 13.5m to a residual height of 11m. Lateral branch length reduced by 2m to an overall crown spread of approximately 8m.To increase light to garden and begin pruning cycle to manage the size of the tree and its location.

4.5 TA/2018/1239

Demolition of a redundant modular building, fence line adaptation and associated works. Installation of a new double modular unit, comprising 2 No classrooms, WCs, Stores and Lobby. Temporary Planning Permission for 2 academic years to accommodate pupils at St Mary's School (adjacent) whilst the works to facilitate expansion of that school (permitted under reference TA/2018/92) is completed.

Downs Way School, Downs Way, Oxted RH8 0NZ

The Parish Councillors object to this application. Local roads cannot accommodate any additional parking; there is inadequate on-site parking for staff. Oxted Parish Council must be involved to approve construction traffic management plan to ensure consideration of the local roads and residents is taken into account. The Parish Councillors are passing their concerns to County Councillor McIntosh.

If the application is approved the works must be undertaken during the Summer break to minimise risks to the safety of pupils and staff.

Erection of internal stud partition wall incorporating doorway across existing ground floor hall to form utility room and toilet and provision of built in cupboards. (Listed Building Consent) Mayflower Cottage, Broadham Green Road, Oxted RH8 9DF
