- **1.** <u>**Apologies for absence:**</u> received and accepted apologies for absence. Cllr Liz Parker
- 2. <u>Declarations of Disclosable Pecuniary Interest:</u> To receive any disclosure by members of personal interests in matters on the agenda, the nature of any interests, and whether the member regards the interest to be pecuniary under the terms of the Code of Conduct. 4. <u>Matters arising from the Councillors inspection of the burial ground prior to the meeting</u>

- Hedge along the stream to be reduced to a height of 6ft
- All burial notifications to be circulated to all Burial Ground Committee members
- Weekly maintenance report to be circulated to all Burial Ground Committee members

5. <u>Burial Ground</u>

- Burial Process the current process which was circulated at the meeting was discussed. Amendments and improvements to the process were suggested. Action: Clerk
- Burial ground capacity it was agreed the north corner needs to be measured to obtain an idea of how many spaces will be available.
- Communications with Alex Jones following discussion it was agreed Cllrs Matt Sapsford and Peter Giles will meet with Alex Jones
- Tenders it was agreed the Clerk will place an advert in County Border News inviting tenders to be submitted for the burial ground works
- Burial Ground Working Party the next working party date was agreed as Saturday 12th October. The plan will be to continue uncovering neglected memorials

6. <u>Burial Account</u>

Receipts and Payments schedule – the schedule which had been previously circulated was briefly discussed. Concern was expressed regarding an income source for the burial ground should the reduction in bookings continue.

7. <u>Future Works</u>

Disabled parking slope; Widening of roadway – The Clerk confirmed that, although quotes are received for the works, the jobs appear to be too small for the organisations quoting. All members were required to provide details of tarmacadem organisations. Action: All Entrance gate – date for works to be undertaken awaited as gate is being made

Action: Clerk to chase the maintenance person undertaking the gate works
