# <u>MINUTES</u>

# 1. <u>Election of Chairman</u> Cllr Denize Wallace nominated Cllr Giles, Cllr Sapsford seconded. Elected one abstention

- 2. <u>Election of Vice Chairman</u> Cllr Katherine Saunders nominated by Cllr Giles. Elected
- 3. <u>Apologies for absence:</u> There was none received.
- **4.** <u>**Declarations of Disclosable Pecuniary Interest:**</u> To receive any disclosure by members of personal interests in matters on the agenda, the nature of any interests, and whether the member regards the interest to be pecuniary under the terms of the Code of Conduct. Members are reminded of the need to repeat their declaration immediately prior to the commencement of the item in question. Anyone with an interest must, unless an exception applies, or a dispensation has been issued, withdraw from the meeting. There was none declared
- 5. <u>Public session:</u> There was no member of the public present

# 6. <u>Matters arising from the Councillors inspection of the burial ground prior to the meeting.</u>

- Two new watering cans were purchased and installed in the burial ground
- Left hand side of burial ground adjacent to the roundabout does not appear to have been cut recently although either end does
- Long grass around base of trees requires strimming
- A lot of grass cuttings are covering numerous memorials
- Weeds require cutting back along the stream
- The path towards the circular bench requires weed treatment
- Where the new plots are being dug there are some large weeds growing between them.

#### 7. <u>Burial Ground</u>

• Roundabout works – Following discussion it was agreed quotes are required for the block paving of the roundabout to enable the council to ratify the request to fund the works including the new bench. It was also suggested that box sections be installed around the edge of the roundabout.
