Comment: The Parish Councillors expressed their concern about the proposed unsympathetic development. There are many mature trees on the site which require protecting if the development proceeds to ensure the tree roots are not damaged. With the site being so steep there is a risk that during the extensive excavation for the garage that this could destabilise the main building. A retaining wall would be required, and this is not shown on the plans. The rear extension is large with a flat roof, and it does not appear that the design fits with the current property and the proposal is out of keeping with the character of the existing dwelling.
