Erection of 6 no. flag poles, 2 no. monolith boards, 2 no. hangman signs, 5 no. banners, 3 no. welcome signs.

Comment: The Councillors consider the time period required is excessive; the flag poles should not be erected, and the advertising signs are excessive and intrusive.
