Erection of aluminium pergola to front patio area to support and include a retractable roof 28-30 Station Road East, Oxted RH8 0PG

Erection of replacement single storey building. Workshop Rear of, Service Station, High Street, Oxted RH8 9LN Applicant: Mr Jai Acharya **Comment: In considering the application the Parish Council has found no material planning reasons for refusal however insist that the trees are retained.**

4.3 TA/2023/1210

Erection of a WeBuyAnyCar office pod (Revised plan and Highway technical note) 43 East Hill, Oxted RH8 9AE

Applicant: WM Morrisons Ltd

Comment: The Councillors consider the location proposed is inappropriate in the car

park. Concern was expressed regarding how the cars will be removed from the car park as bringing a transporter into the car park will be problematic. Concern was also expressed regarding the number of parking spaces occupied by vehicles waiting to be removed.

Alterations to existing fenestration, replacement of existing kitchen extract system including new roof-mounted plant (over upper ground floor) and new external plant compound. Moorhouse School, Mill Lane, Hurst Green, Oxted RH8 9AQ

4.5 TA/2024/83

Re-positioning of rear retaining wall and associated alteration of ground levels, erection of a ground floor rear single extension, erection of a two-storey side and rear extension and changes to front and rear fenestration.

G1) - 2x Oak - on right-hand side of rear garden. Overhanging crown reduced back by up to 3m. Remaining branch length of at least 6m from branch stem.

T1) - Oak - on right-hand side of rear garden - Overhanging crown reduced by 2.5m.

Remaining branch length of at least 7m from main stem.

T2) - Beech - Overhanging crown reduced laterally by 2.5m. Remaining branch length of up to 7m from main stem.

T3) - Sweet Chestnut - In close proximity to outbuilding and leaning towards house - Fell.

Replant with 1no standard Acer campestre (Field Maple) 10-12cm girth.
