MINUTES

- 1. <u>Apologies for absence:</u> to receive and accept apologies for absence. There were none received.
- **Declarations of Disclosable Pecuniary Interest:** To receive any disclosure by members of personal pecuniary interests in matters on the agenda, the nature of any interests, and whether the member regards the interest to be prejudicial under the terms of the new Code of Conduct. Anyone with a prejudicial interest must, unless an exception applies, or a dispensation has been issued, withdraw from the meeting. There were none declared.
- 3. <u>Public session:</u> There was one member of the public in attendance in respect of application TA/2024/514. The Councillors listened to the comments raised for which the Chairman thanked the resident for attending the meeting. With the agreement of the committee this application was brought to the beginning of the agenda.
- 4. To consider and make comment on the following Planning Applications:

4.1 TA/2024/447

Creation of driveway and dropped kerb

28 Johnsdale, Oxted RH8 0BP

Applicant: Mrs Katie Kerr

Comment: The Councillors do not object to the application however consideration does not appear to have been given to the discharge of water from the aqua channel. Prior to approval this needs to be addressed.

4.2 TA/2024/514

Demolition of the existing bungalow and erection of a replacement dwelling, landscaping and associated works.

7a Paddock Close, Hurst Green, Oxted RH8 0LQ

Applicant: Mrs Jamie Alley

Comment: In considering the application the Parish Council has found no material planning reasons for refusal. Planning and design statement was extremely useful. The Councillors were

pleased to note that the applicant took on board the views and comments raised with the original application.

4.3 TA/2024/89

Demolition of existing dwelling. Erection of a replacement dwelling. (Amended Plans) 5 Bluehouse Lane, Oxted RH8 0AA

Applicant: Mr & Mrs Francis

Comment: The Councillors object to this application due to the overbearing nature and not in keeping with surrounding area. There is also overlooking of neighbouring properties and loss of natural light into the garden. The Councillors did not consider that this application is materially different to the original application.

4.4 TA/2023/1230

Erection of single storey extensions and associated alterations to Chestnut Building to provide 3x additional classrooms.

Hazelwood School, Wolfs Hill, Limpsfield, Oxted RH8 0QU

Applicant: Mrs Melanie Mercer

Comment: The Councillors have no objection to the building however expressed concern regarding parking and number of cars that will be on the highway. A report from Surrey Highways is requested. It is suggested that the school should also investigate the feasibility of more on-site parking.

4.5 TA/2024/548

Erection of Part 2 storey extensions to the North and South sides of the existing house. Change of flat roof to pitched roof to front of the house and change of flat roof to the existing garage to a double pitched roof.

7 Icehouse Wood, Oxted RH8 9DN

Applicant: Mr C Neil

Comment: In considering the application the Parish Council has found no material planning reasons for refusal.

4.6 TA/2024/188

Formation of new off-road parking in part of front garden. Vehicle crossover from public highway, gravel section across grass verge, leading to inclined gravel driveway with stepped timber retaining parts. Gravel sections bordered with timber frame.

28 Barrow Green Road, Oxted RH8 0NL

Applicant: Mr Shuttleworth

Comment: The Councillors consider a Surrey Highways view is required due to the location of the proposed vehicle crossover and the impact on the verge and pedestrian walkway.
