## 1. **Apologies for absence:**

There were none received.

#### 5. Burial Ground

• Title deeds are to be registered. Clerk will follow up with solicitor and, if no response, will request refund of funds already paid and will seek an alternative solicitor.

Consideration was given to possible selling plots in advance of being required.
